An important step in the normalization of Argentina's economy

International media this month widely reported on the country's return to credible inflation statistics after the revamped Indec statistics agency announced figures for May 2016. An important step in the normalization of Argentina's economy, the publication of reliable inflation data "is expected to lead to a positive audit from the IMF, due in July, which will mark the first time the multilateral organization performs its Article IV economic review in South America's second-largest economy since the previous government severed relations in 2006" (Financial Times)

Susana Malcorra's candidacy for UN Secretary General received extremely strong endorsement from Colombian President Juan Manuel Santos during President's Macri's state visit to Colombia, as did Argentina's bid to become part of the Atlantic Partnership commercial alliance. Santos "Colombia wants to be Argentina's door to the Pacific", stated President Santos (AFP).

a tax amnesty to encourage Argentines to repatriate billions of dollars was also widely reported. President Macri declared that the amnesty "would help fulfill one of his campaign pledges to settle debts with pensioners, some of which date back more than two decades" (Bloomberg). The fact that Argentina has recently signed information-sharing agreements with dozens of countries will, according to Finance Minister Prat Gay, make it "very hard for Argentines who don't have things in order to hide money that they haven't yet declared. Because of that we're offering them a last chance"

Business media reported on announcements by national and international companies to expand services and investments in Argentina. Banco Galicia, for example, Argentina's largest bank, will "spend more than 2.5 billion pesos (US\$182 million) in 2016 to open branches, move its headquarters and incorporate new technology, compared to 1.3 billion pesos invested last year" (Reuters). Exxon Mobil is looking at additional investments of over US \$10 bil-

lion in the next few decades, as it transplants the U.S. shale-drilling model to Argentina's Vaca Muerta. (Bloomberg).

A highlight of President Macri's state visit to Colombia and participation at the World Economic Forum Latin America in Medellin in mid-June was his call for greater innovation across Latin America. Together with President Santos, Macri urged for new technoloFinally, in a wide-ranging interview with El Pais, Cabinet Chief Marcos Pena discussed subjects ranging from the country's shifting image abroad after Kirchnerismo and the situation in Venezuela, to the recent tax amnesty and consistent levels of support for the government across Argentina society.

#### The President's aim is to invest 6% of GDP in infrastructure

Interior Minister Rogelio Frigerio announced that the government's goal is to invest 6% annual GDP in infrastructural works through public-private partnerships, thereby "boosting the competitiveness of exports and achieving greater social inclusion." Between 2016 and 2019, investments of \$30 billion are expected. Read more
